THIS PROCESS INCLUDES THE USE OF DOCUMENTED COMPARABILITY DATA AND LEVERAGES THE TRUSTEES' KNOWLEDGE OF ECONOMIC CONDITIONS, THE FISCAL STRENGTH OF THE ORGANIZATION, THEIR KNOWLEDGE OF SIMILAR ORGANIZATIONS (OFTENTIMES FROM PERSONAL INVOLVEMENT), THE RESPONSIBILITIES OF THE POSITION IN QUESTION, AND EXTERNAL RESEARCH (USUALLY ON THE WEB).
